If your business is importing plastic packaging (either primary, secondary, or tertiary), you must register with the Central Pollution Control Board (CPCB) and obtain an EPR certificate. This registration ensures that importers take responsibility for the post-consumer plastic waste generated from the products they introduce into the Indian market. Without a valid EPR certificate, clearance of plastic consignments can be delayed or denied by customs authorities.
